- One art sample demonstrating your talent for which you are applying for scholarship: VHS or DVD for **Dance, Drama or Film**; CD, DVD or VHS for **Music**; One typed writing sample (1,000 word limit) for **Literature**; 5-10 images submitted as originals, photos, CD or DVD for **Visual Art**.
